(Dubai), China, Philippines, Vietnam, South Korea and India for coming all the way from far away places to participate in the 6th Asian Yoga Sports Championship at Vietnam. It was informed by Secretary General, Asian Yoga Federation that due to some unavoidable reasons the teams from Bangladesh, Srilanka and Indonesia could not come to participate in the 6th Asian Yoga Sports Championship, however they have sent their best wishes for the success of 6th Asian Yoga Sports Championship and given the assurance to participate in the 7th Asian Yoga Sports Championship.

The Secretary General, Asian Yoga Federation also conveyed his sincere thanks on behalf of the house to Mr. Leo Lee, President, Yoga Federation of South Korea, who came all the way from South Korea on the request made by Mr. Ashok Kumar Aggarwal, Secretary General, Asian Yoga Federation only two days earlier to the championship.

Sh. Ashok Kumar Aggarwal, Secretary General, Asian Yoga Federation also informed that on the request of Yoga Federation of India, the Ministry of Youth Affairs & Sports, Govt. of India has declared Yoga as one of the sports and has placed it in the category of 'priority Sports'. However, Mr. Kumareswaran, President, Yoga Federation of Singapore offered to host the 7th Asian Yoga Sports Championship in Singapore as per rules & regulations and terms and conditions of Asian Yoga Federation. The house cheerfully accepted the request of Mr. Kumareswaran and unanimously allotted the 7th Asian Yoga Sports Championship, 2017 to Yoga Federation of Singapore to be organized at Singapore.
